The following Supply Chain Code of Conduct is expected of our vendors, suppliers, sub-contractors, and outsourced staffing services ("partners").

## Supply Chain Code of Conduct

#### Our commitment to helping the world thrive

The Coconut Traveler aims to explore the world safely, responsibly, and sustainability. We understand that supply chains supporting the tourism industry must be sustainable and regenerative - balancing the needs of each destination now with the needs of future generations.

We can achieve our purpose only by working closely with our partners. Our Supply Chain Code of Conduct defines our minimum expectations that partners uphold in their commitment to fair and safe labor practices, environmental responsibility, and compliance with applicable laws.

### **Expectations of Our Partners**

#### 1. Obey the law

- 0 Know and follow the laws that apply to them and their business in their destination.
- Treat legal requirements as a minimum standard.

#### 2. Conduct business with integrity

- o Compete fairly and ethically for The Coconut Traveler's business.
- o Never offer or accept improper incentives connected with the business.
- Avoid any conflict of interest relating to financial interests or other arrangements with our employees that may be inappropriate.





#### 3. Honor business obligations

- Share our commitment to conducting business honestly and transparently.
- o Honor business obligations and manage proactively, timely, and open way.
- Maintain accurate and honest records, which helps us make responsible business decisions and disclose truthful and timely information to our stakeholders.

#### 4. Treat people with dignity and respect

- Provide safe and healthy working conditions at all of their operations.
- Never use or tolerate human trafficking, forced labor, or child labor as defined by the International Labor Organization (ILO).
- o Foster an inclusive work environment that is free of harassment and discrimination.
- Meet or exceed all legal requirements for compensation and working conditions.

#### 5. Be a responsible global citizen

- o Maintain strict standards to promote tourism with regenerative goals as a priority.
- Strive to reduce environmental impact by minimizing greenhouse gas emissions and waste and using resources efficiently.
- Protect water resources by minimizing the use of water in their operations, avoiding contamination from their operations, and reducing the impact on the water resources of the surrounding communities.
- Respect the free, prior, and informed consent concerning indigenous communities' resources and tenure rights.
- Work with The Coconut Traveler to implement sustainable processes and correct problems to drive continuous improvement and societal value.





### **Vetted Partners**

The Coconut Traveler commits to responsible tourism's "shared value" aspect. This means that we strive to create flows of capital that remain local for the benefit of the community. Additionally, we prioritize mission-aligned and underrepresented organizations.
